

**SZIGET X BUDAPEST PARK VIP UPGRADE
PRIZE GAME
RULES OF PARTICIPATION**

These present Rules of Participation (hereinafter: „**Rules**”) set forth the terms of participation in the and prize game (hereinafter “**Game**”) to be held under the name “**Sziget X Budapest Park VIP Upgrade**”.

Organiser of the Game. The Game is organised by **Sziget Cultural Management Ltd.**, (1033 Budapest, Hajógyári sziget, hrsz. 23796/58., Hungary; tax number: 26189905-2-41; registration number: 01 10-049598, hereinafter “**Organiser**”) organizing Sziget Festival 2026 (hereinafter “**Event**”).

The term of the Game. The Game shall be held between 12:00, July 20, 2026, and 24:00, July 26, 2026 (CET). The Organiser reserves the right to change the term of the Game.

Participants of the Game. Any individual having full legal capacity over 18 (eighteen) years old may participate in the Game (i) who, prior to the term of the Game (i.e. prior to 12:00, July 20, 2026) has subscribed to the newsletter of **Budapest Park** operated by **Kultúrpark Zártkörűen Működő Részvénytársaság** (seat: Budapest, Fábrián Juli tér 1., Company Reg. No.: Cg. 01-10-140483) and (ii) by use of the referral link included into the Budapest Park newsletter sent prior to the beginning of the Game purchases, during the term of the Game, purchases daily ticket to the Event at the webshop of the Event (www.szigetfestival.com) (hereinafter each a „**Player**”, together “**Players**”). The Organiser points out that the Game does not apply to the Day of Bródy Songs and Sziget Icons Day, which are associated with the Event; these events are not covered by these Rules, and therefore individuals who purchase one-day tickets for these days will not participate in the Game. Only such pass purchase transaction entitles to the participation in the Game which has been finished in accordance with the General Terms and Conditions applied by Organiser (available here: <https://szigetfestival.com/en/policy-gctc>). By conducting a ticket purchase complying with the previous conditions, the Player accepts the provisions of these Rules without any further legal action and acknowledges the contents hereof as legally binding.

The proprietors and executive officers of the Organiser, Kultúrpark Zrt. and other contributors having a role in carrying out the Game, their employees, agents, and their close relatives (Ptk. 8:1 § (1)) may not participate in the Game as Players.

Description of the Game. On behalf of Organiser, Kultúrpark Zrt. draws attention to the Game in newsletter. From among the Players, one (1) winner (hereinafter each a “**Winner**”, together “**Winners**”) will be chosen by drawn in respect of each day of the Event covered by the Game (August 11, August 12, August 13, August 14 and August 15, 2026) whose prize (hereinafter each a “**Prize**,” together “**Prizes**”) is a VIP terrace admission ticket for two valid for the day on which the daily ticket purchased for the Event is used, to the VIP terrace located at the Budapest Park by Johnnie Walker venue of the Event. Accordingly, the Prize for a given day will be awarded by drawing among the Players who purchase a daily ticket for that day. The Organiser points out that the Game does not apply to the Day of Bródy Songs and Sziget Icons Day, which are associated with the Event; these events are not covered by these Rules, and therefore individuals who purchase one-day tickets for these days will not participate in the Game.

One Winner will be chosen for each Prize.

Draw of the Winners, receiving the Prizes. The Organiser will select, through random drawing, the Winners among the Players, on July 27, 2026. The Prize may not be exchanged for money. Neither the Winner, nor others are entitled to demand from the Organiser to exchange the Prize to money or to any other gift. The Organiser does not provide any other gifts or prizes in the Game other than that is determined. No additional Winner will be selected if the Winner loses his or her right to receive the Prize or does not fulfil his or her obligation in the given term to get the Prize, or he or she refuses to get the Prize.

The Organizer will provide Kultúrpark Zrt. with the Winners' names and the email addresses they used for the ticket purchase. The Winners will be notified on the Prizes by Kultúrpark Zrt. via electronic mail to the email address used for the purchase and simultaneously therewith, the voucher(s) necessary for accessing the Prizes will also be sent.

Each Prize will be delivered on 1 (one) occasion as follows. By delivering the Prize, the Organiser verifies the entitlement for the Prize only on basis of the e-mail address presented by the Winner. The Organiser and Kultúrpark Zrt. expressly excludes its liability connected with the eventual abuses related to the receipt of the Prize. The Organiser draws attention to the fact that the Prize (VIP terrace admission ticket for two) may be accessed only in case of attending the Event. Without attending the Event, the Prize cannot be accessed.

Legal characteristics of the Game. The Game shall be deemed as a prize draw not qualifying as a gift draw. The Organiser undertakes to pay the personal income tax directly applicable to the Prizes and the amount of any additional tax or other contributions directly related to the Prizes.

General provisions. The implementation of the Game and the participation therein shall be in accordance with these Rules. The Organiser excludes any liability arising out of any abuse.

Liability matters. If there is abuse or any suspicion of abuse during the time of the Game, the Organiser reserves the right to suspend or to terminate the Game or to exclude the offender from the Game. In such a case, the Organiser excludes its all liability.

The Winner bears all consequences of giving incorrect personal data or if his/her mailbox cannot receive letters. The Organiser is not able to check the correctness of the aforementioned personal data. In this regard the Winner shall exclusively bear all responsibility and all legal and financial consequences.

The Organiser excludes any liability for any demand for compensation or indemnification or for any cost, damage, loss incurred by the Players as a result of participating in the Game. By participating in the Game, the Player expressly waives his or her right to have any demand relating to conducting the Game, the Prize, the Winner, the Organiser or any other third parties.

The Organiser excludes its liability for any copyright infringement.

The Organiser shall not bear any liability if the webpage that contains these Rules periodically cannot be found due to technical reasons during the term of the Game. The Organiser shall not be liable for problems with the webpage and for their consequences beyond its control (for example technical problems or break-down in the internet system).

Data handling. The e-mail address provided by the Winner will be processed by Sziget for the purpose of delivery of the Prize. Sziget only stores these data until the end of the Game and use of the Prize. The legal basis for data processing is the participant's consent pursuant to Article 6 paragraph (1) a) of the 2016/679 regulation of European Parliament and Council (GDPR). Consent may be withdrawn at any time by sending an email to dpo@sziget.hu. Such withdrawal does not affect the lawfulness of processing based on consent before its withdrawal. Organiser informs the Players that beyond the arrangement of the Game, the email address used for the purchase of the pass(es) is also processed for other purposes, for which the applicable privacy notice is available here: <https://szigetfestival.com/en/policy-gctc#!/c141/privacy-policies> (*Privacy policy concerning purchases for festivals organised by Sziget Zrt.*).

For the purposes of conducting the Game, the Organiser will verify whether, during the term of the Game, individuals who purchased a daily tickets for the Event in accordance with these Rules did so using the referral link included in the Budapest Park newsletter and, accordingly, are participating in the Game as Players. In order to deliver the Prizes, the Organiser will provide the names and email addresses of the Winners to Kultúrpark Zrt.

Pursuant to the GDPR, during the data processing, the participant may request access to the personal data and may request information about data processing (which will be provided by Organiser within no more than 1 month), may request rectification or erasure of personal data or the restriction of data processing.

If you feel that Organiser as controller has violated any of the legal provisions applicable to data processing, please contact Organiser first, using the above contact information, or at the following email address: dpo@sziget.hu.
